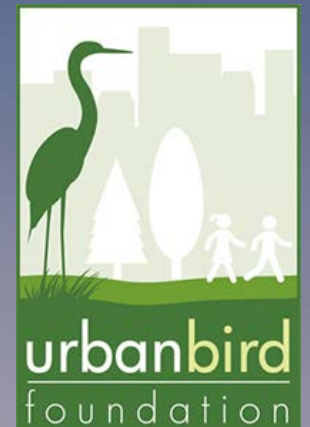

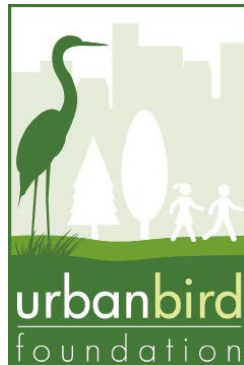

Dear Friends,

With you at our side, Urban Bird Foundation has beat the odds and significantly impacted the conservation of birds in our urban and suburban communities.

In true grassroots fashion and in keeping with our history of challenging the status quo, we pursued the conservation of burrowing owls and open spaces, sought the creation of publicly accessible habitats that provide homes for wildlife and educational opportunities for students, and rescued injured birds from house finches to ducks to great horned owls – frontline, on-the-ground action for the benefit of birds, people, and communities.

Our approach continues to link field research, citizen science, habitat protection, and hands-on restoration projects with community involvement and education – a tactic that not only leads to greater protection of urban and suburban habitat and wildlife, but to lasting public engagement in local conservation efforts.

We as a conservation community must take a position against unrestrained mitigation outside of the region where development has impacted species and habitat. And we must identify, protect, and properly manage local open spaces and habitat fragments to ensure they remain suitable for wildlife.

You were behind every single success Urban Bird Foundation had over the last year. Standing together, we

will continue to protect local birds, preserve open spaces, and save burrowing owls across the country. Together, we:

- Testified at the Florida Fish and Wildlife Conservation Commission, which helped get the Florida burrowing owl listed as state threatened.
- Partnered with the Sierra Club and Banning Ranch Conservancy to set a California Coastal Commission precedent that increased the protection for migratory raptor habitat in Southern California.
- Delivered a mixed-use proposal to establish Napa County's first brick and mortar wildlife rescue and rehabilitation center.
- Fielded more than 1,800 calls for wildlife and habitat help and emergencies, provided field-learning experiences to 600 children, and protected or restored 89 acres of urban habitat.

We're honored to be a part of this forward-thinking community of birders, conservationists, community advocates, and you, the donors and volunteers, who make it possible.

florida burrowing owl listed as state threatened!

On November 16, 2016, the Florida Fish and Wildlife Conservation Commission (FFWC) approved the staff recommendation to upgrade the status of the Florida burrowing owl (*Athene cunicularia floridana*) from Species of Special Concern to state Threatened on Florida's Endangered and Threatened Species List.

During the FFWC meeting, Urban Bird Foundation partnered with South Florida Audubon Society, testified, and delivered support for upgrading Florida burrowing owls to Threatened status, our pledge of support and collaboration, and our endorsement of burrowing owl conservation recommendations.

Identified threats to the Florida burrowing owl include:

- Loss of native habitat and the resulting dependence on altered habitat.
- Lack of protected habitat, even for rural burrowing owls.
- Lure of potentially hazardous habitat, such as predevelopment activities (vegetation clearing) resulting in sites that mimic native habitat of the burrowing owl.
- Urban area threats, including vehicle collision, predation or injury by domestic animals, and burrow destruction by mowers or other equipment.

critical wintering habitat saved

Urban Bird and partners successfully prevent the loss of burrowing owl wintering and foraging habitat in Newport Beach, California

Urban Bird Foundation in coordination with leading organizations Sierra Club Angeles Chapter and Banning Ranch Conservancy successfully prevented the loss of burrowing owl wintering and foraging habitat in the Banning Ranch area of Newport Beach, California. In a hearing on September 7, 2016, the California Coastal Commission upheld staff burrowing owl habitat protection recommendations and voted to deny the Banning Ranch development proposal that planned for the construction of 895 homes, a hotel, and shops on the Southern California coast. The approval of this project would have destroyed open space and eliminated critical burrowing owl habitat in Orange County.

After championing increased environmentally sensitive habitat area designations for Banning Ranch burrowing owls, the conservation organizations learned on August 25, 2016 that their efforts were successful when the California Coastal Commission issued a revised report that identified 64 acres of burrowing owl burrow and foraging habitat. The original Coastal Commission report identified only 1.5 acres and would have effectively eradicated the wintering owl habitat.

“We are celebrating this incredible victory for California’s declining burrowing owl population,” said Scott Artis, Executive Director of Urban Bird Foundation. “Since the state is considered one of the most important wintering grounds for migratory burrowing owls, it is imperative to protect the foraging and over-wintering habitat along Southern California’s coast.”



napa county's first wildlife rescue center



Plan includes environmental community center, wetland mitigation & wildlife hospital

Urban Bird Foundation joined the American Canyon Clarke Ranch Master Plan process as a stakeholder with the goal of establishing a wildlife rescue hospital.

On December 12, 2016, Urban Bird Foundation delivered a mixed-use proposal that supports maintaining the current open space for the benefit of wildlife, residents, and the Napa River and Bay Trail visitors, and building a wildlife rescue center – the first brick and mortar hospital and rehabilitation facility to treat injured wildlife in Napa County.

The adjacent Napa River Bay Trail and open space provides great views of the wetlands and constructed ponds as well as public access to the Napa River. The site provides habitat to hundreds of wildlife species including burrowing owl, river otters, and migrating shorebirds, and through a system of trails offers recreational opportunities like hiking, birdwatching, photography, cycling, and on-leash dog walking.



In September 2017, a preferred master plan was selected that includes a wildlife rescue center, an environmental and community center, and expanded wetland mitigation. The final plan will be taken to the American Canyon City Council for consideration of final adoption in October 2017.

Urban Bird is confident the city will adopt the final proposal - a plan that will increase protections for local wildlife, environmental education, and volunteerism.

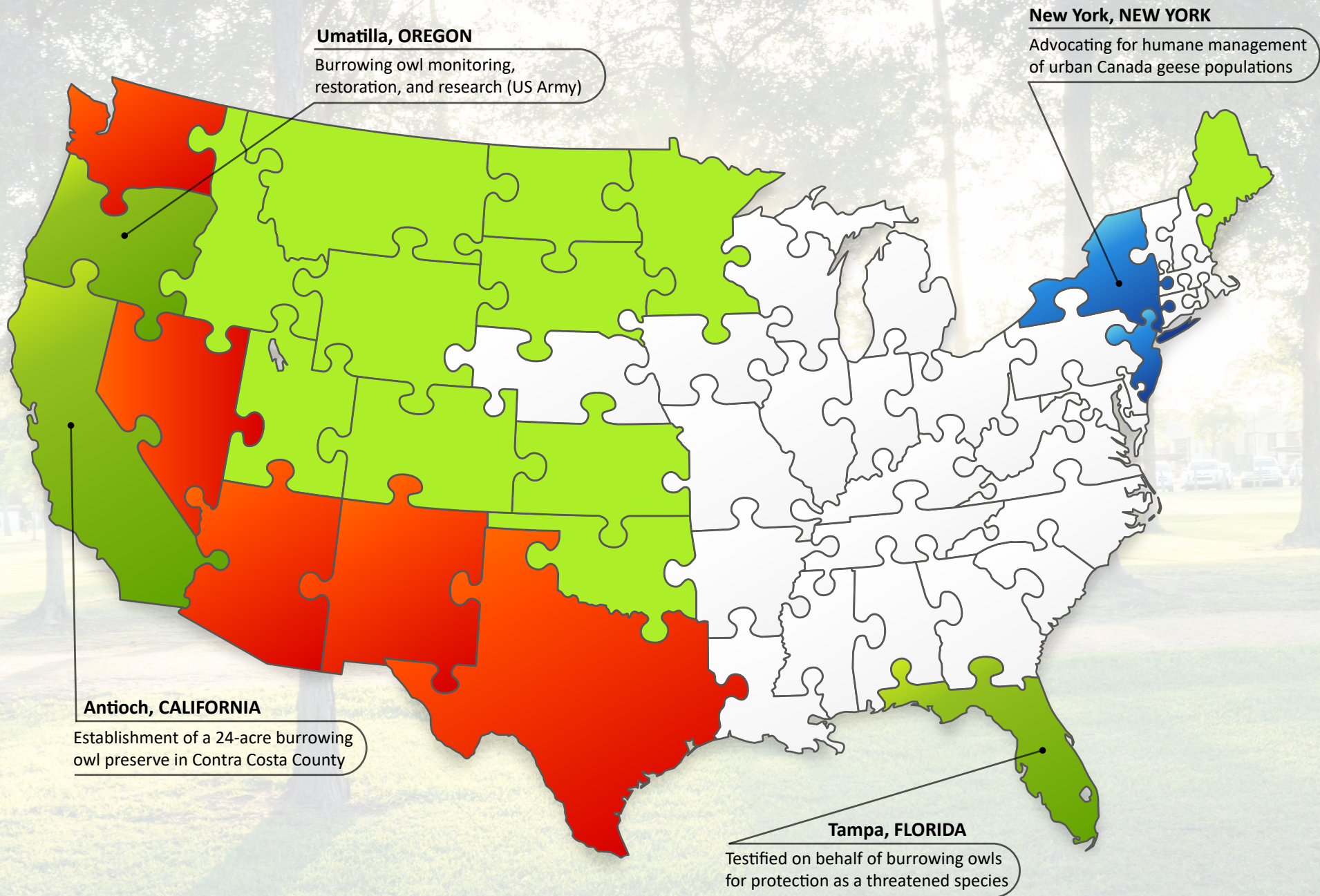
